The event occurred on **11/29/2019** at approximately **18:04** at **1823 M STREET NW, WASHINGTON, DC 20036**

BWC activated.

All events occurred at 1823 M St NW in PSA 208 within the District of Columbia.

Officer Michael Diemer and Officer Suzanne Burkholder were in full uniform, operating marked MPD vehicle 2081 and utilizing call sign 2083.

Officers Diemer and Burkholder received a radio run for a mental health consumer and Destruction of Property at Camelot located at 1823 M St NW. On arrival, C-1 (Chang, Edward) and C-2 (Triantis, Nicholas) were standing outside with Defendant Sina Augusto Iman's brother and a female. It was reported Defendant Iman, his brother and the female had been inside for several hours consuming alcoholic beverages. When Defendant Iman was presented with the bill, he became irate and started throwing glasses, bottles and chairs. Defendant Iman then went outside of the establishment, picked up a sandwich board sign and threw it at C-1's vehicle. C-1 was standing outside and witnessed this action. C-1's vehicle sustained minor damage to the front passenger door and the sandwich board sign broke from the impact. Defendant Iman then fled east in the 1800 block of M St NW without paying the money owed for the bill.

Defendant Iman's brother called him, convinced him to return to 1823 M St NW and when he arrived, C-1 and C-2 began yelling, "That's him!" Defendant Iman was placed under arrest for Misdemeanor Destruction of Property and transported to the Second District for processing.

The cost to repair the damage done to C-1's vehicle is unknown, C-2 stated the sandwich board sign cost \$190.00.

Photos of the damaged vehicle and the sandwich board sign were uploaded to Evidence.com.

Defendant Iman was identified by his California driver's license as Sina Augusto Iman with a DOB of 11/20/1989.

The event and acts described above occurred primarily in the District of Columbia and were committed as described by defendant(s) listed in the case caption.
